\$1 MILLION-PLUS HIGHLIGHT

John Glades West AKA Uptown Boca Receives \$126M

The largest March commercial loan in Palm Beach County was made by Jutland Finance, Inc. The \$126.65 million mortgage was contracted by Glades 95TH Owner LLC for three tracts of land in West Boca for the new John Glades West project, a 38-acre retail and apartment development entitled Uptown Boca. Additionally, First Republic Bank and Bank of America NA contributed significantly to a three-month increase of 19% in the \$1 million-plus commercial mortgage category for the first quarter of 2019, as compared to Q4 2018. First Republic Bank awarded the most mortgages, eleven altogether; while Bank of America made the largest fiscal investment at \$35.9 million. The 19% increase for Q1 represents a total of \$1.7 billion versus \$1.55 billion during Q4 2018.




