\$193M Mortgage Kick Starts Via Mizner 2021 Boca Project

The 105 East Camino Real 1 LLC issued the top July mortgage loan in the amount of \$192.5 million to Via Mizner Owner III on a 5-lot parcel in the Spanish River Land subdivision. The new mortgage includes reassignment of \$22.5 million in outstanding notes, as well as invests approximately \$170 million into the venture to be known as The Residences At Mandarin Oriental, Boca Raton, to be completed in 2021. The loan contributes to a total of \$1.79 billion in the total value of Palm Beach County Commercial Mortgages during the last three months in the \$1 million-plus category, a 5% increase as compared to the three months prior. On the residential side, DB Private Wealth Mortgage LTD lent Vahan H. Gureghian \$25.7 million, the largest mortgage to an individual during the last 12 months, beating the \$21.7 million dollar home mortgage awarded to Christopher Warner Blackstone in favor of JPMorgan Chase Bank NA, last March.




