## HarborChase Assisted Living Receives \$40M

Last month's largest commercial mortgage was provided by Synovus bank, a $\$ 40.3$ million loan secured on the newly opened assisted living facility, HarborChase of Palm Beach Gardens, located at 3000 Central Gardens Circle. Silverstone Palm Beach Gardens Owner LLC was the mortgagor. The largest residential mortgage in Palm Beach County was a significant $\$ 16.25$ million loan in favor of Citibank NA on Palm Beach property, 589 N. County Road. The mortgagor was Robert P. Stiller. Additionally, the top four county mortgages all went to The Town of Palm Beach, contributing $\$ 42.9$ million in residential investment. The second largest loan, $\$ 11.9$ million, went to Charles M. Adams on 1104 Seminole Boulevard in favor of City National Bank of NA. Valerie J. Winchester secured $\$ 5.5$ million on 200 Clark Avenue in favor of BNY Mellon NA, and Michael T. Fries secured $\$ 4.65$ million on 146 Seaspray Avenue in favor of JP Morgan Chase Bank NA.
