

Mediterranean Style Mansion in Phipps Estates Brings \$9M

New Inventory and Sales Run Neck and Neck in September-Sales Dominate Q3

The Corcoran Group kick-started the month by closing an \$8.95 million purchase of an 8,000-plus square foot residence in Phipps Estates on September 1st. The Mediterranean-style mansion at 240 Via Las Brisas boasts 15-foot ceilings, a marble staircase, covered outdoor dining, and a northern exposure. Manuela Yanez of William Raveis listed the property and Dana Koch of the Corcoran Group represented the buyer. During September, fifteen single-family homes were sold and fourteen single-family homes entered the market in the \$1 million-plus category. While running neck and neck for the month, inventory and sales experienced a 58% differential during the third quarter, where 46 homes entered the market and 80 homes left the market, as compared to 65% more listings than sales during the same period of last year.

Patricia Mahaney of Sotheby's International Realty led luxury listings with her presentation of the Mediterranean Revival estate on the ocean end of Brazilian Avenue. The In Town property has an asking price of \$8.8 million. Dana Koch of the Corcoran Group presented the second highest listing of \$8.5 million for 208 W. Indies Drive, a 5-bedroom Bermuda style home designed by Amanda Lindroth.






MEDIAN SELLING PRICE* Current Year Versus Prior Year




HOMES SOLD* Current Year Versus Prior Year

September Inventory Flush With 34 Luxury Condo Listings

The Third \$7M-plus Palazzo Villa Townhome Sale Makes Top 10

Together, Ashley McIntosh and Christopher Leavitt of Douglas Elliman listed the third Palazzo Villa townhome to place in the Top 10 Sales of the last 12 months. In this latest September transaction, McIntosh and Leavitt shared the listing while Leavitt represented the buyer for 215 Brazilian Avenue, closing at \$7.4 million.

The Palm Beach luxury condo inventory experienced a large influx of new listings in the \$1 million-plus category in September with the addition of 34 properties. The Corcoran Group offered six units in the new 3550 South Ocean building, just completed in 2019. Agents Mia Morrison and Steven Presson shared listings for apartments 3B, 3E. and 5D, and Suzanne Petrizzi presented apartments 2B and 2C. Arno De Vos of Douglas Elliman added Penthouse 6A, and altogether the asking prices for the seven 3550 South Ocean condominiums totaled \$21 million.

Fern Fodiman of Sotheby's International Realty listed the two priciest condominiums of the month, a \$6.50 million Penthouse in the prestigious Palm Beach Hampton building, and a \$5 million 5th floor corner unit at the oceanfront Sun And Surf One Hundred And Thirty.










MEDIAN LISTING PRICE* Current Year Versus Prior Year

SKA Architect's \$2.6M El Vedado Plans are Underway

Commercial Construction Begins at the Former Testa's Restaurant Building

Rogers General Contracting was granted the largest permit last month, which was also in the Top 10 of the last 12 months. The residential alteration project is valued at \$2.6 million and will renovate a sprawling estate located on the prestigious El Vedado Road. SKA Architect designed the enhancements for the traditional-style, red-brick estate that will include a restructured white-columned entranceway, and 840-square-foot stand-alone gym and a 650 square-foot dome-topped cupola.

Two additional major projects are also underway according to September permits. Whittmann Building was contracted to erect a new \$1.42 million estate at 260 Plantation Road that entails razing the current residence, landscape and hardscape, and building a two-story West Indies style residence and pool designed by Dailey Janssen Architects. The third largest permit issued in September was for a \$1.23 million commercial alteration to be built by Coastal Construction which entails a buildout of interior retail space at 223 Royal Poinciana Way (formerly Testa's Restaurant) and included a use-of-row sub permit to pour a topping slab in the back section.




TOTAL VALUE OF PROJECTS* Current Year Versus Prior Year


TOTAL NUMBER OF PROJECTS* Current Year Versus Prior Year

Last 12 Months


