## \$1 MILLION-PLUS HIGHLIGHT

## \$63.6M FOR WATER TOWER PHASE II CONSTRUCTION

 JP Morgan Invests \$174M in Million-plus PBC Mortgages August Through OctoberThe Lantana II Owner company filed both Mortgage and Notice of Commencement documents on October 19th for the Water Tower Commons in Lantana where Phase II of their multi-use project will proceed. CIBC Bank USA is backing the development with a $\$ 63.6$ million commercial mortgage loan.

In the $\$ 1$ million-plus category of Palm Beach County mortgages, JP Morgan contributed to a $20 \%$ increase in commercial loan dollars and a $14 \%$ increase in residential loan dollars during the last three months by issuing the most loans of both loan types including 10 commercial mortgages with a value of $\$ 53.72$ million, and 38 residential mortgages with a value of $\$ 120.58$ million, totaling $\$ 174.3$ million altogether.
