## \$42.6M Launches New Boca Beach House Construction

## First Republic Provides Mortgage for Former John Lennon Property Purchase

Bank OZK lent Boca Lake Acquisitions LLC $\$ 46.2$ million to commence construction of the waterfront luxury condominium project, Boca Beach House Luxury Residences \& Marina located at 725 S. Ocean Boulevard where there will be 32 residences, five-star concierge service, and a private marina on Boca Beach.

On the residential side, the First Republic Bank awarded November's largest mortgage in Palm Beach County to the 720 South Ocean Land Trust, a $\$ 19.6$ million loan, for the purchase of the former John Lennon mansion at 720 S. Ocean Boulevard in Palm Beach from John Sikes who sold the property for $\$ 36.08$ million. The deed and mortgage were both posted on November 2nd.
