\$1 MILLION-PLUS HIGHLIGHT

Year 2020 Realized a 67% Gain in High End Residential Mortgages

Developers Help Commercial Loans Double in One Month

CIM Credit LLC awarded developer Group P6 \$68.5 million to begin construction on their luxury residential project, Royal Palm Residences, in Boca Raton. This, as well as the second largest loan, a \$66.66 mort-gage that went to JCBRFL001 LLC secured on two parcels at Park at Broken Sound, formerly known as the Arvida Park of Commerce, in favor of CitiBank NA, contributed to a \$219% increase in \$1 million-plus mortgages in Palm Beach County in December as compared to November. December's total in the category was \$585.8 million while November's total was \$183.5 million, helping to offset an otherwise modest year, where 2020 saw a 23% decrease as compared to 2019. However, on the residential side, there was a 67% increase in \$1 million-plus home mortgages.






