\$95M Loan For Icon Marina Village Launches Construction 30% Increase in \$1 million-plus PBC Commercial Loans During Q1

March's largest commercial mortgage was a \$95 million loan awarded to RD IMV Owner LLC, whose registered agent is Corporate Creations Network of North Palm Beach, in favor of Santander Bank NA. The paperwork was filed on the 15th, and soon thereafter a Notice of Commencement was filed for Icon Marina Village, a 19-plus-acre integrated development project in West Palm Beach that will include two rental towers located at 4444 and 4334 North Flagler Drive. RD IMV Owner LLC filed the NOC with Balfour Beatty Construction LLC named as the contractor. Overall, lenders continue to signal optimism in local business with public records showing a 30% increase in \$1 million-plus commercial mortgage loans during Q1 as compared to the prior three months.








