Big Money Rolls In for Apartments, Condos & an Island

Lenders seemed to line up for investment opportunities in Palm Beach County last month with the big loans going to residential housing and the purchase of an island. Mesa West Core Lending Fund LLC provided the top loan, a \$77.05 mortgage for the \$112 million purchase by Ch Realty IX MF Boca Raton Congress LP of Alta Congress, a 369-unit aparment building in Delray Beach. The second largest, a \$69 million loan, went to FCI Camino LLC in favor of PNC National Bank Association to break new ground for the Camino Square apartment/retail project in Boca Raton, formerly the Winn-Dixie shopping center. The third largest, a \$60.2 million loan from US Bank National Association, went to Olen Properties for their rental property, The Hamptons at Palm Beach Gardens that they purchased in December of 2020. Additionally, an entire island in Palm Beach was bought by 10 Tarpon Island LLC, where a \$58.83 million loan in favor of FRYD Mortgage LLC helped finance the \$85 million purchase.




VALUE OF LOANS


