

# Agent Angle Leads the Pack of New Listings with Pricey \$85M Manse Malasky Family Built, Owned and Brokered October's \$19M Top Sale

October's largest sale was the 5,913-square-foot home at 12 Via Vizcaya in the prestigious Estate Section. Stephen Malasky of Malasky Homes acted as the selling agent, and, along with his brother Bruce Malasky, is also a co-successor trustee of the property. Malasky Homes, founded by their father, Donald Malasky, built the home in 2007. The property closed at \$18.22 with Elizabeth DeWoody representing the buyer.

Meanwhile, a healthy slew of listings entered the market in the \$1 million-plus category, twenty altogether with Christian Angle of Christian Angle Real Estate's property at 203 S. Lake Trail, a rare 1.6 acre In Town estate priced at \$84.9 million, leading the pack. Additional stellar offerings include 576 Island Drive on Everglades Island, and 1080 S. Ocean Boulevard, ideally located two blocks north of Mar a Lago, priced at \$29.85 and \$26.85 respectively. Lawrence Moens of Lawrence A. Moens Associates presented both. Additionally, Jim McCann of Premier Estate Properties brought 301 Polmer Park Road to market, an 8500 square-foot North End estate priced at \$24.85 million.





## MEDIAN SELLING PRICE\* Current Year Versus Prior Year




## HOMES SOLD\* Current Year Versus Prior Year

#### Breakers Row Sale Tops \$10M Third Month in a Row

Two \$9M-plus Listings Lead an Influx of Condo Listings

The largest October sale, Apartment 21n of Two North Breakers Row listed by Dana Koch of The Corcoran Group brought \$10.51 million. The sale was the third Breakers Row condominium to top \$10 million. Apartment 31n closed for \$12.08 million in July and Apartment 42n closed for \$13.75 million in August. Lawrence Moens of Lawrence A. Moens Associates and Tom Shaw were the listing and the closing agents of the July sale, and Cristina Condon and Greg Forest of Sotheby's International Realty were the listing and closing agents for the August sale.

Along with the single-family home category, the \$1 million-plus condo market also had good showing in October with nineteen new listings, including two \$9 million-plus properties. Christopher Leavitt of Douglas Elliman presented the largest, a five thousand square-foot Italian inspired villa at 331 Australian Avenue for \$9.48 million, and Rosalind Clarke of Premier Estate Properties presented Penthouse C at 300 S. Ocean Boulevard, advertised as a "stunning Penthouse apartment in the coolest mid-century building in Palm Beach," for \$9.3 million.






#### MEDIAN SELLING PRICE\* Current Year Versus Prior Year




### CONDOS SOLD\* Current Year Versus Prior Year

#### \$3.2M Landscaping Project to Commence at 304 Garden Road

Town Quiets Down: Construction Requests Decrease 28% and Issued Permits Decrease 44%

A \$3.2 million landscaping project is about to commence on the newer North End estate at 304 Garden Road. The West Indies-style white-columned residence was constructed as a spec home developed by the luxury homebuilder E. Llwyd Ecclestone III in 2017, and just resold last May for \$23.79 million after only two weeks on the market. The new landscaping plans include demolition of a pool, installation of a new pool, spa and fountain with new gating and planting in those areas, plus window and door modifications, and the relocation of a generator.

During the last three months of August through October, the number of Development Review requests for future projects decreased 28% as compared to the same period of last year, and permits issued to begin building construction large scale projects of \$100 thousand-plus also decreased, by 44%. Altogether, the valuation for large-scale project permits issued during the three-month period totaled \$44.28 million.





### TOTAL NUMBER OF PROJECTS\* Current Year Versus Prior Year





#### TOP 5 BY VALUE OF PROJECTS\* for Last 12 Months






