## Residential Property Highlight: \$5M-Plus Single Family Homes

## Another 3 Sales Surpassed \$30M Each Last Month

Much like January's home sale market, three outstanding transactions that hit and/or surpassed the thirty-million-dollar mark were chalked up in February. In what is referred to as South Florida's Malibu on the Atlantic, the prestigious and gated Highland Park community, the oceanfront estate at 2445 S. Ocean Boulevard brought $\$ 36$ million. Joseph Liguori of Premier Estate Properties listed the property for $\$ 42$ million in November, and Marcy Javor of Signature One Luxury Real Estate represented the buyer in the sale.

Sonja Stevens of Sotheby's International Realty represented both the buyer and seller of the second largest sale, 110 Clarendon Avenue, located in the Estate Section on Palm Beach Island. The newly renovated property brought $\$ 32.65$ million and features a Mediterranean style mansion, a two-story guest house, and over 14,200 square feet of real estate. Lawrence Moens of Lawrence A. Moens Associates listed the third largest sale, a property with 150-plus feet of prime waterfront and advertised as 'a remarkable storybook landmark estate'. Matthias Fretz of Douglas Elliman represented the buyer in the $\$ 31.67$ million sale.

## 3 Miami Condo Sales Top the Chart at \$20M-plus Each

Mirroring the Florida single-family home market, three Miami condo sales also outpaced the competition by a significant margin. Two are located on ultra-exclusive Fisher Island at Palazzo Del Sol and Palazzo Del Mare. The first of which, the $\$ 21.25$ million purchase of Unit 6812, 6800 Fisher Island Drive was both listed and closed by Dora Puig of Luxe Living Realty. In the purchase of 7153 Fisher Island Drive, Erena Stus represented the seller and Elena Bluntzer represented the buyer.

In the largest condominium sale of the state last month, the new home-owner paid $\$ 23$ million for Unit S511 of 9001 Collins Avenue. Roberta Ingletto of RGI Realty represented the seller and Michael Duchon of the Corcoran Group was the closing agent. Designed by Brazilian architect Carolina Protod, the ocean-facing corner unit includes custom millwork, a gourmet Boffi kitchen, Italian travertine floors, and a 1,300 square-foot terrace.
