## RESIDENTIAL PROPERTY HIGHLIGHT: \$5M-PLUS SINGLE FAMILY HOMES

## Palm Beach Estate No. 1 in \$3.5B of Q1 Ultra-Luxe Home Sales

There were 372 single-family residence sales in the \$5 million-plus category that were publicly advertised during the first quarter in the State of Florida and they totaled \$3.46 billion altogether. The top three brought \$45.36, \$38.5, and \$36 million and were located in Palm Beach, Miami Beach and Highland Beach, respectively. The top sale closed in March when a sprawling seven thousand square-foot mansion situated at 1330 N. Lake Way on the island of Palm Beach advertised as "A boater's Dream!" became the home of a new owner. Michelle Newman of William Raveis South Florida represented the seller and Christopher Leavitt of Douglas Elliman represented the buyer in the transaction. The second largest sale took place in January when agent Dina Goldentayer of Douglas Elliman helped close on a Miami-Dade waterfront mansion designed by Touzet Studio, located at the prestigious 6395 North Bay Road address. Mirce Curkoski of ONE Sotheby's International Realty represented the seller. The third largest sale closed in February with Marcy Javor representing the buyer of 2445 S. Ocean Boulevard in Highland Beach and Joseph Liguori representing the seller of the stately Cap d'Antibes-inspired oceanfront estate.










# NUMBER OF HOMES SOLD Current Year Vs. Prior Year

## March's \$23.5M Penthouse Sale Tops Q1 Florida Condo Market

The Florida condominium market continued to set new records during the first quater of 2022 with three oceanfront communities in Maimi area leading the sales rush. The top transaction took place in March with the sale of Penthouse 5603 located at the top of the soaring 56-floot tower in the elegant Jade Signature at 16901 Collins Avenue in Sunny Isles Beach. Chad Carroll of Douglas Elliman helped close the \$23.5 million deal and Sandra Chartouni of Fortune International Realty represented the buyer. The second and third largest transactions took place in February. Ryan Farbstein of Douglas Elliman represented the seller of the \$22.5 million Lower Penthouse at 8955 Collins Avenue, a 5 thousand square foot ultra-luxury condo residence at Arte Surfside, of which Tara West of Douglas Elliman held the listing. Dora Puig represented both the buyer and the seller of the \$21.25 million purchase of Townhome 6812 at 6800 Fisher Island Drive, address of the Palazzo del Sol, accessible by only ferry, yacht, helicopter, or seaplane.




MEDIAN SELLING PRICE Current Year Vs. Prior Year
