April's Big Numbers: \$66M Palm Beach Sale, \$100M Golden Beach Listing

Last month, casino mogul Steve Wynn and his wife, Andrea Hissom Wynn sold a lakefront mansion on Palm Beach Island for \$66 million, which was the second largest MLS-advertised sale during the last 12 months. According to The Palm Beach Daily News, the buyer, Robert Stiller, founder of Green Mountain Coffee Roasters, and his wife Christine purchased the newly remodeled estate at 1350 North Lake Way. Lawrence Moens of Lawrence A. Moens Associates represented both parties in the deal.

Further south in the oceanfront community of the Town of Golden Beach, which is situated on the barrier reef between the Intracoastal Waterway and Atlantic Ocean, a mega-estate at 355 Ocean Boulevard was co-listed by Daniel Hertzbert and Jill Hertzberg of Coldwell Banker Realty for \$100 million. With 250 feet of ocean frontage, the property was advertised as having the largest oceanfront in all of Miami.





Penthouse Atop Iconic Palm Beach Tiffany Building Brings \$18M

Average Price Point of Florida Luxury Condos increased 5%

The largest condominium sale of April was an \$18 million transaction closed by Christian Angle of Christian Angle Real Estate. Chris Leavitt of Douglas Elliman is identified as the listing agent in the Palm Bearch Board of Realtors® MLS, and co-listers Jill Eber and Jill Hertzberg of Coldwell Banker Realty are included in separate MLS feeds and local news. The home was built on the rooftop of the landmarked Tiffany & Co. building in Palm Beach. The duplex penthouse condominium at 415 Hibiscus Avenue is the world's only penthouse located on top of a Tiffany's building and was originally priced at \$24 million.

During the three months of February through April, 110 MLS-advertised condominiums in the \$5 million-plus category were sold in Florida. The average median price of the group increased 5% as compared to the same period of the prior year. Helping to augment the healthy increase, eight of the thirty-one properties in the category that were sold in April brought over \$10 million each.






MEDIAN SELLING PRICE Current Year Vs. Prior Year




NUMBER OF CONDOS SOLD Current Year Vs. Prior Year
