REAL ESTATE HIGHLIGHT: HOUSES & RESIDENTIAL LOTS

Fox News' Bret Baier Buys Another Palm Beach Estate-this One, \$37M

Last month, in what is typically one of the slowest real estate months of the year, two sales helped skew up the median average price point of luxury homes to a 46% increase for the summer season as compared to last year. During the months of June through July there were 14 single family home sales in the \$1 million-plus category and the average mean price was \$21.50 million as compared to \$14.75 million last year.

Dana Koch of The Corcoran Group and Christian Angle of Christian Angle Real Estate were August's top performers with their \$37 million closing of 125 Wells Road. Mr. Angle represented the buyer, Bret Baier of Fox News, who also purchased 244 Fairview Road for \$12 million from designer and real estate investor Tommy Hilfiger's ownership company last March, and soon thereafter listed it for \$16.5 million, as reported in the Palm Beach Daily News. Mr. Koch held the listing for the Augustpurchase.

Properties entering the luxury market in August followed the same pattern where a couple of pricey properties contributed to an increased year over year average median during the last three months. Mr. Angle represented the seller of the top August listing, 220 Nightingale Trail, which he tagged at \$29.9 million.






MEDIAN LISTING PRICE* Current Versus Prior Period

Summer Luxury Condo Prices Increase 16% Agents Pulitzer and McCann Close \$14M Deal in August

Summer sales of Palm Beach luxury condos saw a 16% increase in the average mean closing price of \$2.85 million as compared to \$2.45 million during the months of June through August of 2022. Incoming inventory in the \$1 million-plus category during the last three months was slightly less than one half of what it was during the same period in 2022. Supporting the healthy price points, last month James McCann of Premier Estate Properties brought in the buyer for Liza Pulitzer and Whitney McGurk of Brown Harris Stevens' listing of 401 Brazilian Avenue, which closed at \$14 million. Just built in 2003, the spacious townhouse, 1/2 of a Midtown duplex, has almost six thousand square-feet of living space. The transaction was the 6th largest Palm Beach condo sale of the last 12 months.

Of the seven new listings in August, the largest was the pricey \$12 million property presented by Fern Fodiman of Sotheby's International Realty. The condo is located at 130 Sun & Surf, one of Palm Beach's premier resort-style buildings situated directly on the Ocean. Penthouse 1 at 130 Sunrise Avenue is advertised as the Best Value In-Town, with over 3.6 thousand square-feet of freshly renovated living space and soaring ceilings.






MEDIAN LISTING PRICE* Current Versus Prior Period

36% Increase in Large Construction Valuations During Summer Mockingbird Trail Resident Begins \$6M New House Construction

Summer permit valuations indicate a healthy building industry in Palm Beach with a 36% increase in the total valuations of large scale, \$100k-plus projects issued during June through August. Last year's total in the same category and period was \$83.92 million

Last month Sciame Homes was issued a new residential construction permit with a valuation of \$5.5 million for their project at 232 Mockingbird Trail. Associated with the permit is the action of Architectural Commission item ARC-22-142, which reviewed the demolition and new house construction plan 332 Mockingbird Trail as designed by Affiniti Architects.








Top 5 Contractors by Permits











