## Palm Beach Luxury Homes: September Market Highlights

The Palm Beach single-family home market remained strong in September 2025, particularly for properties priced at \$1 million and above. Sales in this segment grew year-over-year, reflecting continued demand for high-end homes in the area. Buyers are competing for well-located, turnkey properties, and inventory in the \$1M+ range remains limited, keeping the market active and pricing robust.

A highlight from the month was the sale of 1214 N Ocean Boulevard, a 5-bedroom, 6.5-bath oceanfront estate built in 1951, which closed for \$37 million. This transaction underscores the strength of the luxury market in Palm Beach and demonstrates how unique, prime-location properties continue to command top dollar, setting a benchmark for other high-end homes in the area.

## Town of Palm Beach: September Luxury Condo Highlights

In September, the luxury condo market in the Town of Palm Beach continued to show strong momentum for residences priced at \$1 million and above. Demand remained high for turn-key units offering ocean or Intracoastal views, refined finishes, and access to premier amenities. Limited high-quality inventory kept competition elevated, and buyers continued to prioritize rarity, location, and lifestyle over sheer square footage—supporting steady strength at the top of the market.

A major highlight this month was the sale of 102 Gulfstream Road, an exceptional ocean-area residence that closed for approximately \$17.2 million. The property was represented by Dana Koch and Paulette Koch of The Corcoran Group, with the buyer represented by Janina Radtke of Sotheby's International Realty. This transaction underscores how best-in-class condos and townhomes in the Town of Palm Beach can soar far beyond the \$1M+ threshold, reinforcing the enduring appeal and premium valuations of the island's most coveted properties.
